⁴ Provider counties offer health care services to eligible low-income persons through county-owned / operated hospitals and clinics consistent with each county's indigent care program rules. Payer counties contract with and/or reimburse providers in the community pursuant to indigent care program rules developed by each county. Hybrid counties operate county clinics and contract with / reimburse private hospitals and providers. Thirty-six smaller counties contract with the County Medical Services Program to administer health care services for low-income individuals pursuant to CMSP program rules set by participating counties.
