# **Remaining Uninsured in California**

### **Revised and updated\***


Prior to the ACA, the uninsured rate for nonelderly Californians hovered between 16 and 19 percent.<sup>1</sup> Although California's implementation of the ACA dramatically reduced the number of uninsured, nearly three million uninsured Californians remain (7 percent of the population, or 8.1 percent<sup>2</sup> of those under age 65). This snapshot provides a quick profile of California's remaining uninsured.

# Who are California's Uninsured?


- Most uninsured Californians (1.8 million or 58 percent) are undocumented, and many are ineligible for existing programs because of immigration status.<sup>3</sup> (Figure 1)
- About 723,000 or 24 percent are eligible for either Medi-Cal or subsidies through Covered California, but not enrolled.<sup>4</sup> (Figure 1)
- Los Angeles County has the largest number of uninsured, 893,000, representing 30 percent of the state's uninsured.<sup>5</sup> (Figure 4)




- As of early 2017, approximately 266,000 California children, or 2.9 percent, were uninsured.<sup>6</sup>
- More than half of the uninsured, 55 percent, are Latino.<sup>7</sup> (Figure 2)








#### Figure 3

- The majority of the uninsured, 1.5 million or 53 percent, are under 200 percent of the federal poverty level (FPL). Another 800,500, or 27 percent, are between 200 and 399 percent FPL, making them income eligible for subsidies to purchase coverage through Covered California.<sup>8</sup> (Figure 3)
