

Race/Ethnicity Breakdown Among Inland Empire Counties with Employer-Sponsored Coverage









**FIGURE 9. Medi-Cal Enrollment in Managed Care and Fee-For-Service (FFS), March 2021<sup>7</sup>**






FIGURE 10. Medicare Enrollment and Percent of Counties' Population, 2019<sup>8</sup>





FIGURE 11. Medicare Enrollment, by Race/Ethnicity<sup>9</sup>
