FIGURE 3. Percent of Counties' Populations Enrolled in Covered California, December 2021³




FIGURE 4. Covered California Enrollment by Race/ Ethnicity, December 2021³




FIGURE 5. Covered California Enrollment by FPL, December 2021³

FIGURE 7. Medi-Cal Enrollment, April 2022^{4,5}




FIGURE 8. Medi-Cal Enrollment by Race/Ethnicity, April 2022⁶




FIGURE 9. Expected <u>CalAIM</u> Implementation Start Date




FIGURE 10. Medi-Cal Enrollment by Managed Care and Fee-for-Service (FFS), April 2022⁷

FIGURE 11. Medicare Enrollment, by Plan Type, Among San Diego and Imperial County's Populations, 2020^{5,8}






FIGURE 12. Medicare Enrollment by Race/Ethnicity, 2020⁸
