#### Remaining Uninsured in California

California benefited more than most states from the Affordable Care Act (ACA) because California fully embraced the ACA opportunities to expand coverage and streamline enrollment and retention processes. This also means that California has the most at stake in federal efforts to repeal or rollback the ACA coverage expansions.

In the years preceding the ACA, the uninsured rate for nonelderly Californians persistently hovered around *20 percent*.<sup>1</sup> Although California's implementation of the ACA dramatically reduced the number of uninsured, approximately *three million* uninsured Californians remain.

California still has a lot of work to do. This fact sheet provides an updated profile of California's remaining uninsured.

#### Profile of the Remaining Uninsured

- California's uninsured rate is currently 7.1 percent.<sup>2</sup> The uninsured rate for nonelderly residents, those under 65 years old, is 8.1 percent.<sup>3</sup> (Figures 1 and 2)
- According to projections for 2017, the majority of the uninsured (1.8 million (M) or 58 percent) will be residents not eligible for coverage due to immigration status.<sup>4</sup> (Figure 3)
- About 723,000 or 24 percent of uninsured Californians are eligible for either Medi-Cal or subsidies through Covered California, but not enrolled.<sup>5</sup> (Figure 3)
- Los Angeles County has the largest number of uninsured residents, at 893,000 or 30 percent of the state's uninsured.<sup>6</sup> (Figure 4)
- The number of uninsured children in California (under 18 years old) has dropped to 335,674 kids or 3.7 percent.<sup>7</sup> (Figure 5)
- More than half of California's remaining uninsured, 55 percent, are Latino.<sup>8</sup> (Figure 6)
- The majority of California's remaining uninsured, 1.5 M or 53 percent, are under 200 percent of the federal poverty level (FPL). Another 800,500 uninsured Californians or 27 percent are between 200 and 399 percent FPL, making them income eligible for subsidies to purchase coverage through Covered California.<sup>9</sup> (Figure 7)


### **Estimates of the Remaining Uninsured**


ITUP relied on multiple data sources to develop this comprehensive profile of California's remaining uninsured. This analysis uses commonly referenced population surveys measuring uninsured populations, including the National Health Interview Survey, the Current Population Survey and the California Health Information Survey. For each of these sources, the survey methodologies, timeframes and analyses vary, and therefore the estimates on California's uninsured, developed using these data sources, will vary. A brief description of each of the population surveys used for this fact sheet, and the respective findings, are included in the addendum.



The following data charts offer a detailed profile of the remaining uninsured in California.

#### National Health Interview Survey







#### California Simulation of Insurance Markets/California Health Interview Survey

The California Health Interview Survey (CHIS) is one of the data sets used in the California Simulation of Insurance Markets (CalSIM). The UC Berkeley Center for Labor Research and Education and the UCLA Center for Health Policy Research developed CalSIM to estimate the impacts of the ACA on health insurance coverage.








NHIS	<ul> <li>In the PAST 12 MONTHS, was there any time when you did NOT have ANY health insurance or coverage?</li> <li>In the PAST 12 MONTHS, about how many months were you without coverage?</li> <li>(Are you/Is anyone in the family) covered by any kind of health insurance or some other kind of health care plan?</li> </ul>
CHIS	<ul> <li>During the past 12 months, was there any time when you had no health insurance at all?</li> <li>For how many months of the past 12 months did you have no health insurance at all?</li> <li>What is the ONE MAIN reason why you did not have any health insurance during those months?</li> <li>During the time that you were uninsured, did you try to find health insurance on your own?</li> <li>What is the ONE MAIN reason why you do not have any health insurance?</li> <li>How long has it been since you last had health insurance?</li> </ul>
CPS ASEC	<ul> <li>Do you (does anyone in your household) NOW have any type of health plan or health coverage?</li> <li>Are you (is anyone in your household) NOW covered by Medicaid, CHIP, Medicare, other State Health program including Exchanges.
