



Figure 1. Potential Impact of COVID-19 on Employer-Sponsored Coverage




Figure 4. Covered California Enrollment by Health Plan, March 2020⁵




Figure 5. Impact of COVID-19 on Covered California Enrollment⁶

Figure 6. Medi-Cal Enrollment and Percent of County's Population, June 2020⁷





Figure 7. Medi-Cal Enrollment by Managed Care Model and Fee-for-Service (FFS), 2020⁸
