Figure 1: Employer-Sponsored Coverage, 2019²

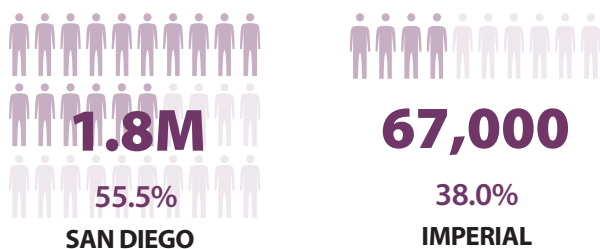
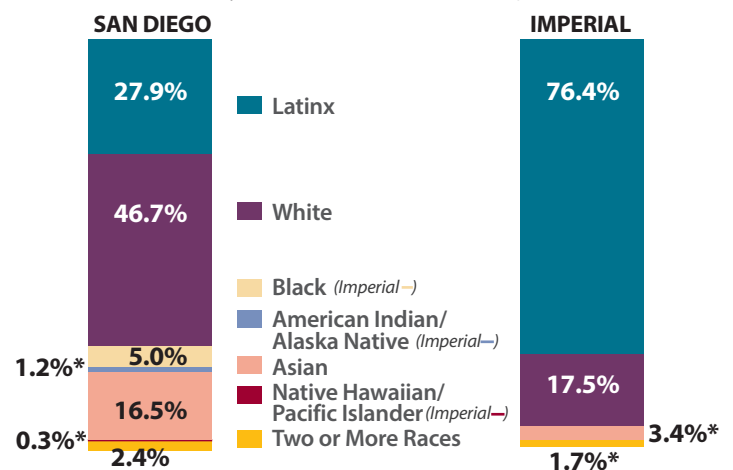


Figure 2: Race/Ethnicity Breakdown Among Californians with Employer-Sponsored Coverage, 2019²

Figure 3: County's Population Enrolled in Covered California, December 2020^{1,3}

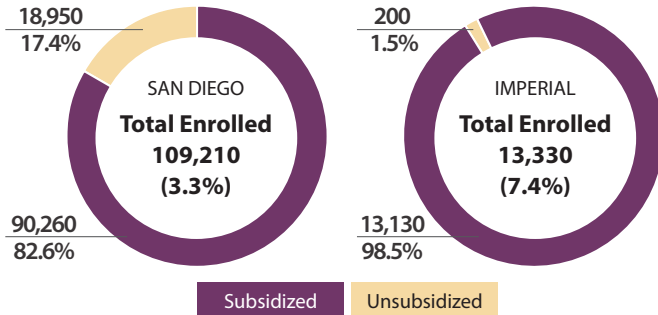

Figure 4: Covered California Enrollment by Race/Ethnicity, December 2020³

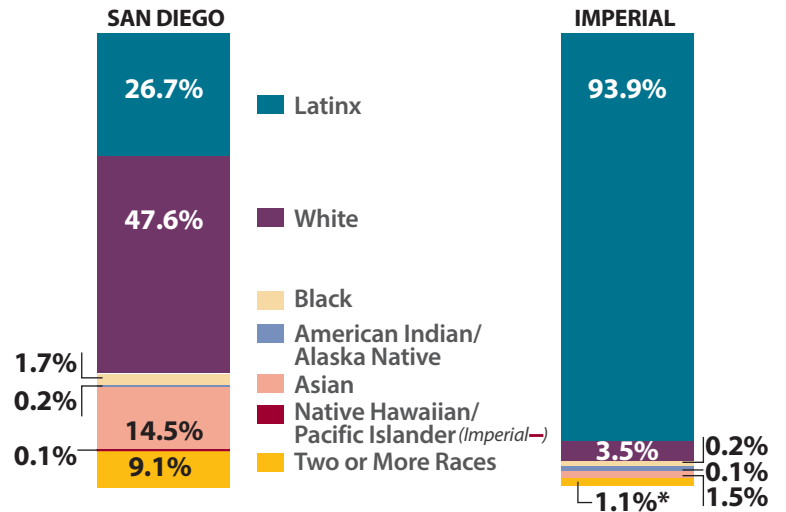
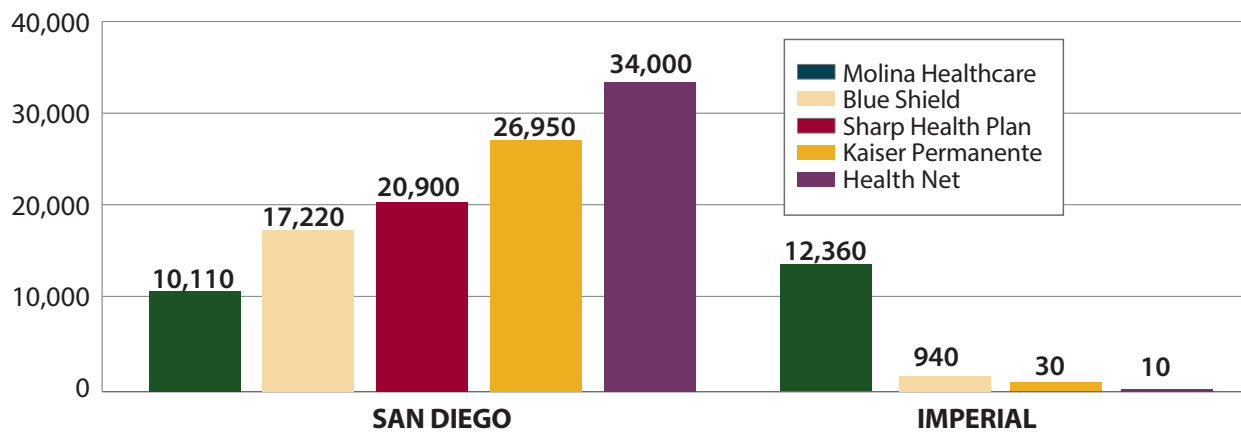


Figure 5: Covered California Enrollment by Health Plan, December 2020³

Figure 6: Medi-Cal Enrollment and Percent of County's Population, February 2021^{4,5,6}

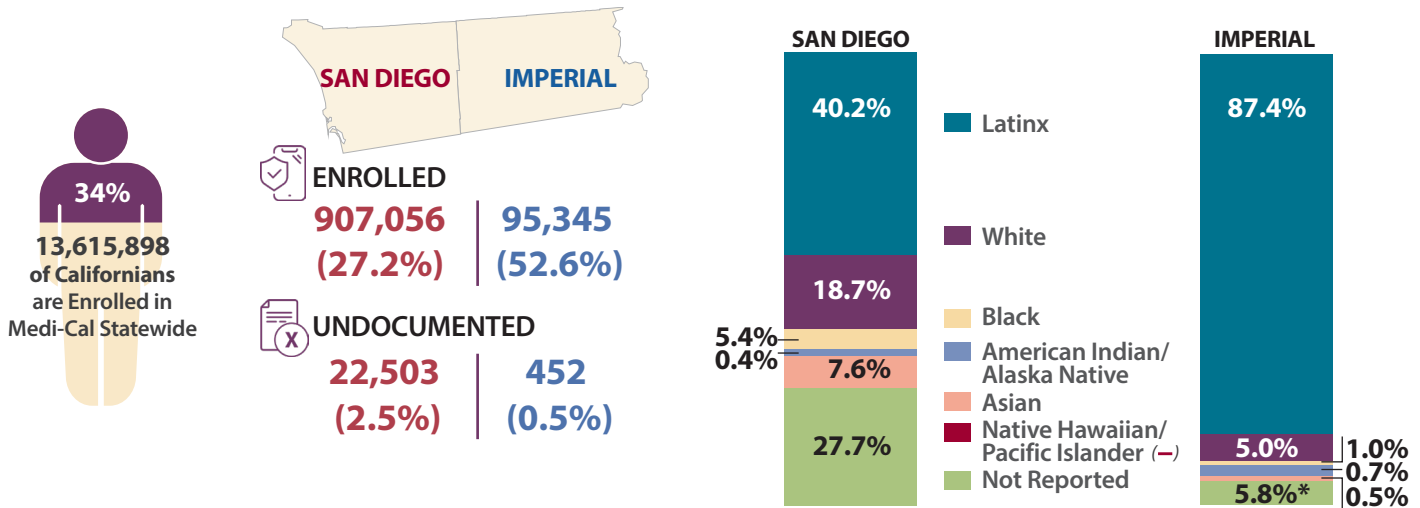
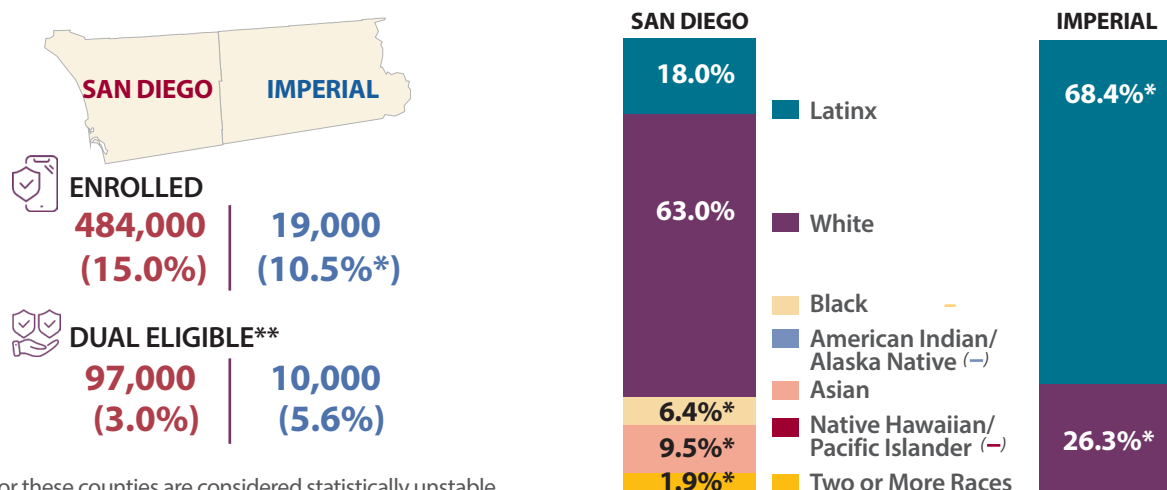
