
#### Figure 1: Employer-Sponsored Coverage, 2019<sup>2</sup>

Figure 2: Race/Ethnicity Breakdown Among Californians with Employer-Sponsored Coverage, 2019<sup>2</sup>



## Figure 3: County's Population Enrolled in Covered California, December 2020<sup>1,3</sup>





### Figure 6: Medi-Cal Enrollment and Percent of County's Population, February 2021<sup>4, 5, 6</sup>





