


FIGURE 1. Race/Ethnicity Breakdown of Counties and Among the Uninsured, 2019³






FIGURE 5. Covered California Enrollment by FPL, December 20204


FIGURE 6. Covered California by Health Plan, December 20204

FIGURE 7. Medi-Cal Enrollment, April 2021^{5,6}









FIGURE 8. Medi-Cal Enrollment, by Race/Ethnicity, April 2021⁷


