



FIGURE 3. Percent of County's Population Enrolled in Covered California, December 20223




FIGURE 4. Covered California Enrollment by Race/Ethnicity, December 2022<sup>3</sup>




FIGURE 5. Covered California Enrollment by FPL, December 2022<sup>3</sup>




FIGURE 6. Covered California Enrollment by Health Plan, December 2022<sup>3</sup>

FIGURE 7. Medi-Cal Enrollment, February 2023




FIGURE 8. Medi-Cal Enrollment, by Race/Ethnicity, February 2023<sup>6</sup>




FIGURE 9. Medi-Cal Enrollment by Managed Care and Fee-for-Service (FFS), March 2023<sup>7</sup>


