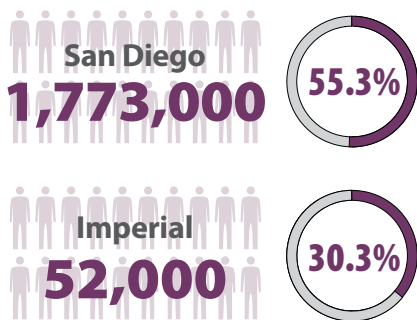
**FIGURE 1. Race/Ethnicity Among the Uninsured, 2021<sup>2</sup>**

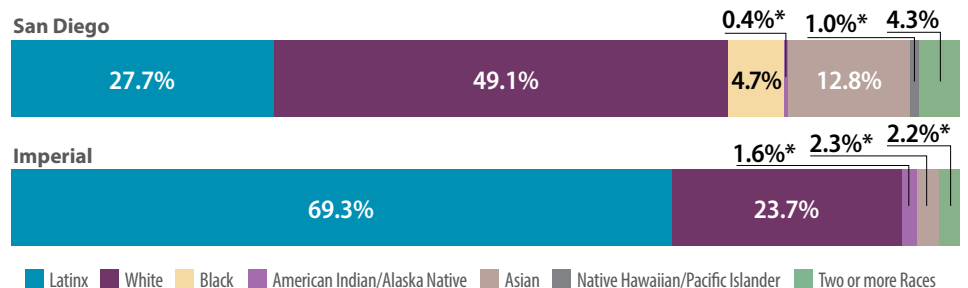

**Race/Ethnicity Breakdown Among San Diego and Imperial Counties with Employer-Sponsored Coverage**



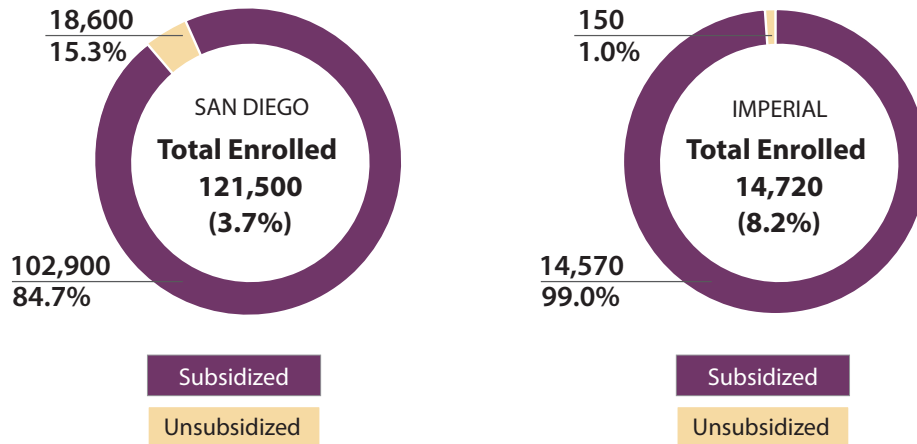

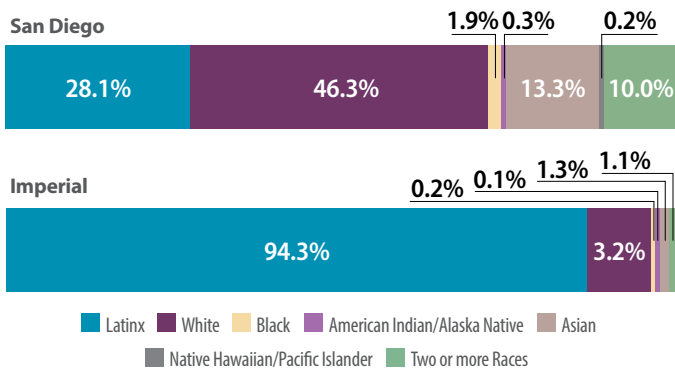

**FIGURE 6. Covered California Enrollment by Health Plan, December 2022<sup>3</sup>**

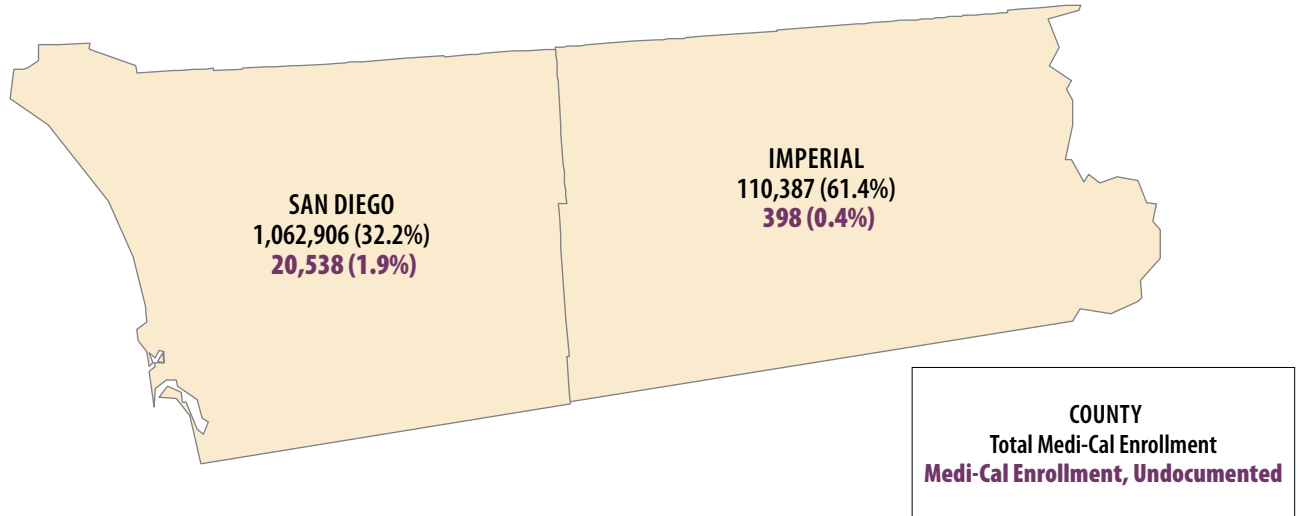

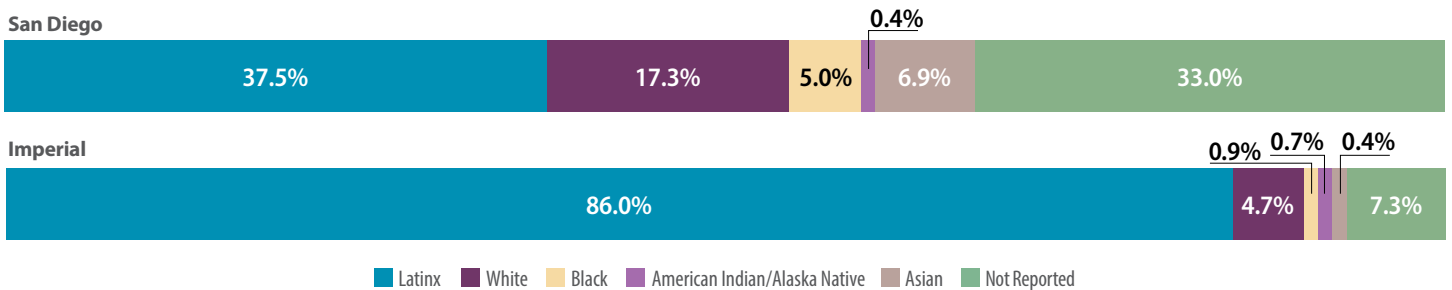

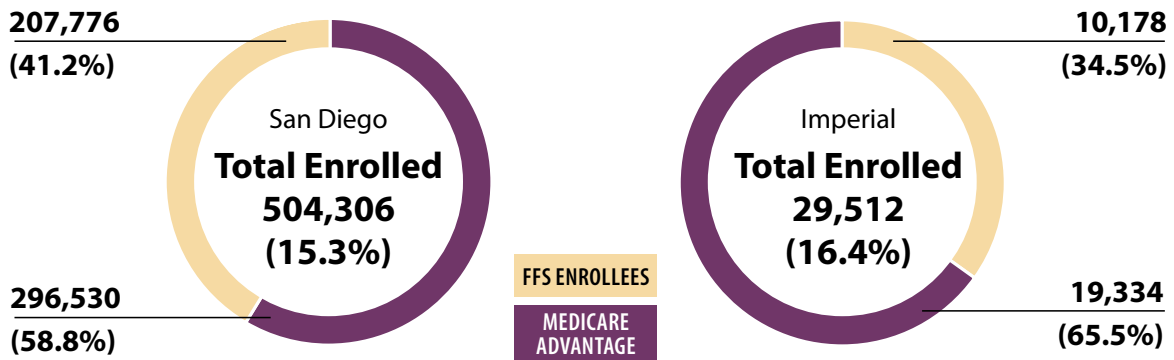

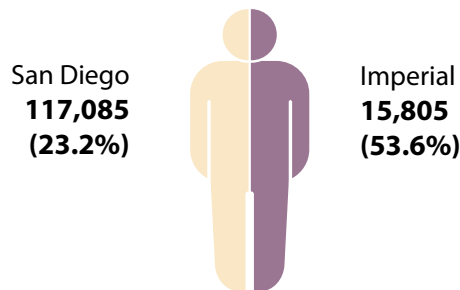

**FIGURE 11. Medicare Enrollment and Percent of Counties' Population, 2021<sup>4,9</sup>**

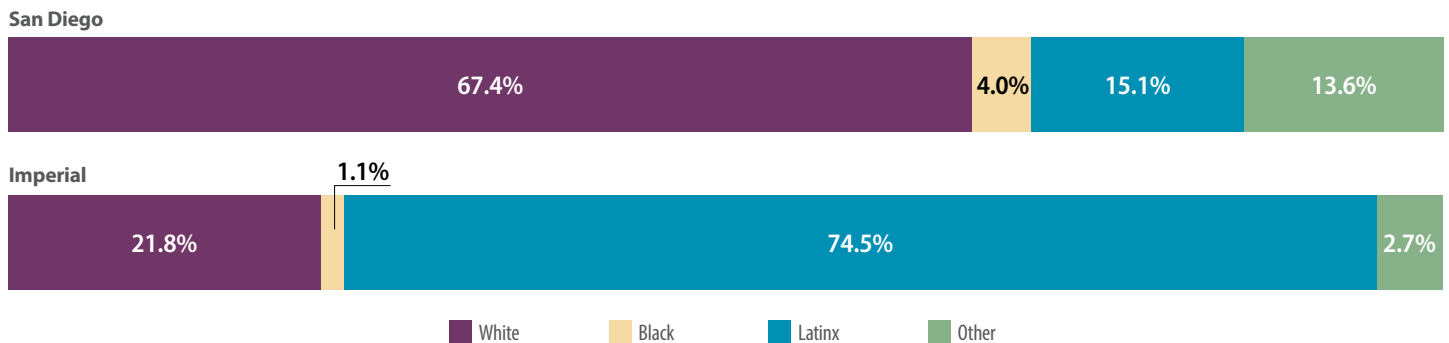
