Key Terms & Definitions:

- **Perinatal:** Refers to the time period from the conception of the pregnancy to one month after giving birth.
- **Medical Racism:** The systematic and wide-spread racism against people of color within the medical system. It includes both the racism in our society that makes Black people less healthy, the disparity in health coverage by race, and the biases held by health care workers against people of color in their care.
- **Toxic Stress:** Occurs when there is excessive or prolonged activation of stress response systems in the brain and body
- Social Determinants of Health (SDoH): Also known as Social Drivers of Health, refers to the conditions in environments where people are born, live, learn, work, play, worship, and age that influence their health risks and overall wellbeing. Some of these drivers include access to safe housing, nutritious food, parks and green space, and even broadband and internet connectivity, all of which impact the ability of and opportunity for Californians to live their healthiest lives.
